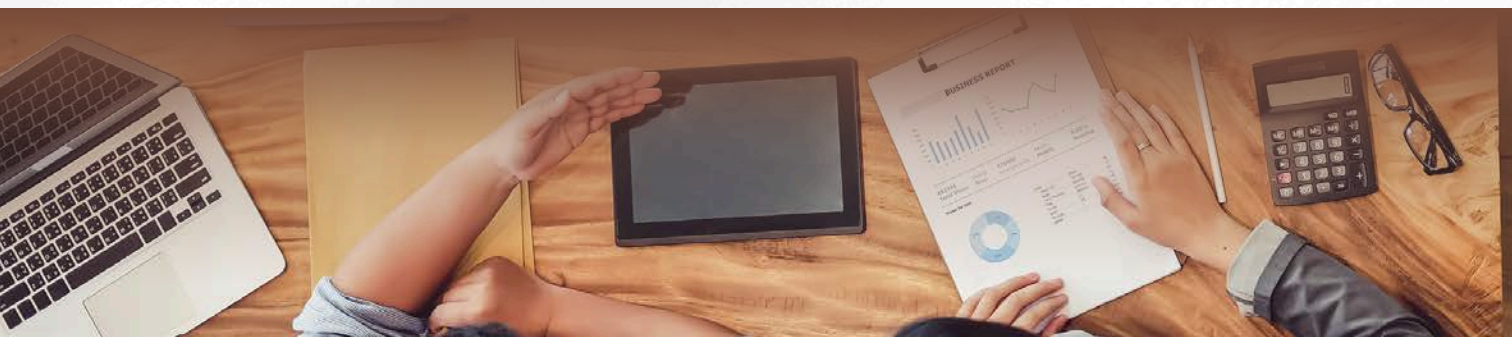

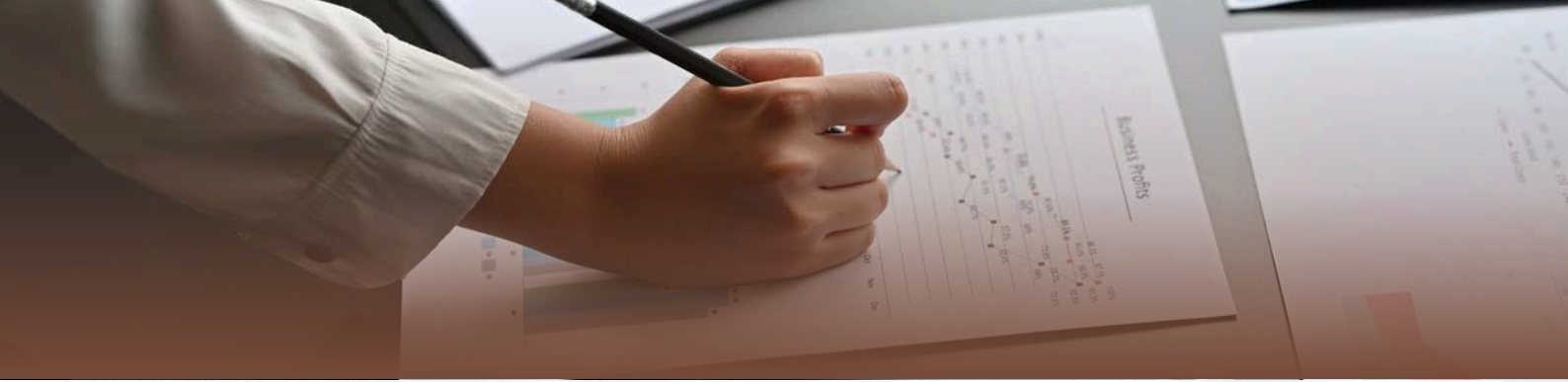

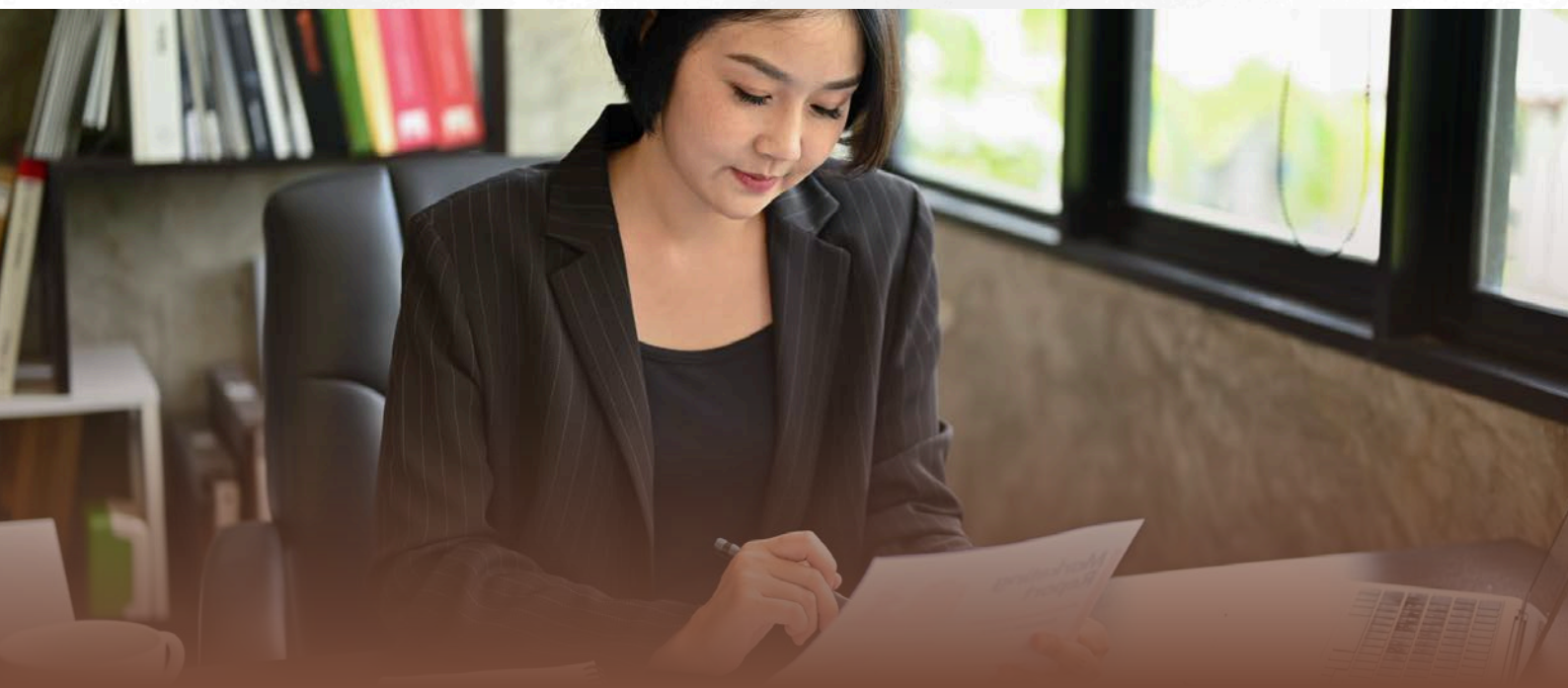

With strong foundations in governance, compliance, and leadership, MCG graduates are in demand across corporate sectors, regulatory bodies, non-profits, and government agencies. Below are some top career paths:

1. **Chief Governance Officer (CGO)**: Leads the governance frameworks, ensuring alignment with corporate strategy, legal standards, and stakeholder interests.
2. **Company Secretary**: Acts as the board's key advisor on governance matters and ensures compliance with statutory and regulatory requirements.
3. **Head of Risk & Governance**: Leads compliance and risk functions, enforcing internal controls and ensuring regulatory adherence.
4. **Governance & Compliance Manager**: Manages governance policies and compliance programmes to support accountability and transparency.
5. **Risk & Governance Consultant**: Advises organizations on improving governance structures, managing risks, and meeting compliance standards.
6. **Internal Control & Audit Manager**: Strengthens internal systems, mitigates risks, and ensures ethical and transparent operations.
7. **Regulatory Affairs Specialist**: Monitors legal changes and ensures the organization complies with relevant laws and policies.

Admission Requirement

- i. A Bachelor's Degree (Level 6 Malaysian Qualifications Framework, MQF) in related fields with a minimum CGPA of 2.50 as accepted by the HEP Senate; or
- ii. A Bachelor's Degree (Level 6, MQF) in related fields with a minimum CGPA of 2.00 and not meeting CGPA of 2.50, can be accepted subject to a rigorous internal assessment; or
- iii. A Bachelor's Degree (Level 6, MQF) in non-related fields with a minimum CGPA of 2.00 as accepted by the HEP Senate and with relevant working experience, subject to a rigorous internal assessment.
- iv. A Bachelor's Degree (Level 6, MQF) in non-related fields with a minimum CGPA of 2.00 as accepted by the HEP Senate and without relevant working experience, subject to passing pre-requisite courses.
- v. Other equivalent/related qualifications to a Bachelor's Degree (Level 6, MQF) recognised by the Malaysian Government.

English Competency Requirement (International Student) :

- Achieve a minimum Band 4 in Malaysian University English Test (MUET) OR equivalent to Common European Framework of Reference for Languages (CEFR) (Mid B2).
